## **ARTICLES OF INCORPORATION**

**Articles of Incorporation** of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

### **ARTICLE I – NAME**

The name of the corporation shall be Our Career Centered Academy PTO, Inc.

### **ARTICLE II – PRINCIPAL OFFICE**

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c) (2) of the internal Revenue Code, or the corresponding section of any future federal tax code.
