



Article III Purpose (continued)

Through events, activities, meetings, lectures, seminars and courses it will inform and inspire the community concerning special needs children and bring about a greater spirit of acceptance and understanding for all. This organization will carry out any other activity or event that is deemed by the president or the directors to be in furtherance of the educational, economic, social or spiritual advancement of special needs students and their families.

Simi's House Inc is empowered to supply all the resources or physical constructions that are deemed necessary by the president or its directors for the practical accomplishment of its purpose, as well for the practice of Orthodox Jewish law or traditions. These include, but are not limited to, religious articles, kosher food, educational materials, or transportation to any event or location which in the view of the president or the directors is required for Jewish practice or the furtherance of special needs children and their families.

Simi's House Inc will conduct its activities in keeping with the letter and spirit of Orthodox Judaism and traditions. It will operate according to the IRS guidelines for a not for profit corporation. It will not distribute dividends to any of its directors or officers. It will not attempt to influence legislation in any way or participate in political campaigns of any sort. In the event of this corporation's dissolution, this corporation's directors will, after paying all debts and liabilities, convey all remaining assets to other charitable organizations recognized by the Internal Revenue Service according to Section 501(c)(3), that have similar purposes.
