The undersigned, acting as incorporators of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation.

ARTICLE I

6. To engage in any other legal business necessary to the achievement goals and objectives.

ARTICLE IV LIMITATION OF POWERS

Notwithstanding any other provision of these articles, the organization shall nor carry on any activities not permitted to be carried on by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Code of 1986 or any corresponding provision of any future United States Internal Revenue Law.

ARTICLE V DISSOLUTION CLAUSE

Upon dissolution of the corporation either as an act of law or by resolution of the Board of Directors assets of the corporation will be distributed to a non-profit 501 (c) (3) corporation. "However if the named recipient is not in existence or is no longer qualified as a distributee , or unwilling to accept distribution, assets of the organization will be distributed to a fund, foundation, or organization which is organized exclusively for purposes specified in section 501 (c) (3) of the Internal Revenue Code.

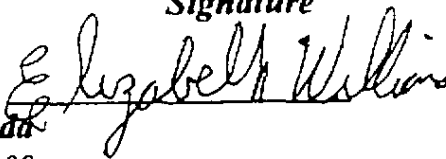

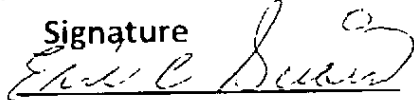
