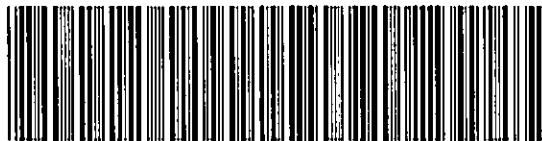

**Articles of Amendment
to the
Articles of Incorporation
of
Save The Closet, Inc., a Florida Not-For-Profit Corporation**

The undersigned, pursuant to Florida Statutes Chapter 617, the Not-for-Profit Corporation Laws of the State of Florida, desiring to amend the Articles of Incorporation for Save The Closet, Inc., Document Number N19000011538, does hereby amend and restate said Articles of Incorporation and does hereby certify the following:

**Article One
Name**

The name of the Corporation shall be the **Save The Closet, Inc.**, a Florida Not-for-Profit Corporation (hereinafter the "Corporation").

**Article Two
Principal Office and Mailing Address**

The place in this state where the principal office of the Corporation is to be located is at 13800 Panama City Beach Parkway, Suite 106-D, #312, Panama City Beach, Florida 32407.

**Article Three
Purpose and Charitable Statement**

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The Corporation has been organized for the specific purpose of providing an entity for donors to contribute funds or goods for the Corporation to provide goods and services to the citizens of Northwest Florida. Save The Closet was created after Hurricane Michael to service the need following natural disasters or life transitions. The Corporation provides Donations With Dignity through a mobile community store, where those in need may 'shop' for free quality clothing, shoes and accessories.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article Four **Manner of Appointment of Directors**

The directors shall be appointed as provided for in the Corporation's Bylaws.

Article Five **Initial Officers and Directors**




**Article Nine

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


