AMENDED ARTICLES OF INCORPORATION

ARTICLE I

1.01 Name

The name of this corporation shall be KINGDOM BUILDERS CHRISTIAN CENTER, I

ARTICLE II

2.01 Duration

The period of duration of the corporation is perpetual.

ARTICLE III

3.01 Purpose

KINGDOM BUILDERS CHRISTIAN CENTER, INC is a non-profit corporation and shall operate exclusively for religious, charitable and educational purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code. The primary purpose (s) of the Organization is to spread the Gospel of Jesus Christ through various lawful activities, avenues and services in accordance with the provisions in the Holy Bible and abiding by the guidance of the Board of Directors. Furthermore, it is the express purpose of this organization to conduct regular worship services through appropriate forms of ministry expression, to preach salvation to the lost, to promote the Christian faith to believers and to collect and disburse any funds necessary for the operation and maintenance of said corporation in the accomplishment of its exempt purposes.

ARTICLE IV

Non-profit Nature 4.01

KINGDOM BUILDERS CHRISTIAN CENTER, INC. is organized exclusively for religious, charitable and educational purposes including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. No part of the net earnings of this Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or

other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.

Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by any organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

This corporation is not organized and shall not be operated for the private gain of any person. The property of the corporation is irrevocably dedicated to its religious and charitable purposes. No part of the assets, receipts, or net earnings of the corporation shall inure to the benefit of, or be distributed to any individual. The corporation may, however, pay reasonable compensation for services rendered, and make other payments and distributions consistent with these Articles.

4.02 Personal Liability

No officer or director of this corporation shall be personally liable for the debts or obligations of the Organization of any nature whatsoever, nor shall any of the property or assets of the officers or directors be subject to the payment of the debts or obligations of this corporation.

4.03 Dissolution

Upon termination or dissolution of the corporation, any assets lawfully available and/or remaining after payment of all debts and liabilities of this corporation shall be distributed to one or more qualifying organizations described in Section 501(c)(3) of the Internal Revenue Code of 1986 (or described in any corresponding provision of any successor statute) which organization or organizations have a charitable purpose which, at least generally, includes a purpose similar to the terminating or dissolving corporation.

4.04 Prohibited Distributions

No part of the net earnings or properties of this corporation, on dissolution or otherwise, shall inure to the benefit of, or be distributable to, its members, directors, officers or other private person or individual, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III. Section 3.01.

4.05 Restricted Activities

No substantial part of the corporation's activities shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in. or intervene (including the publishing or distribution of statements) in any political campaign on behalf of or in opposition to any candidate for public office.

4.06 Prohibited Activities

Notwithstanding any other provision of these Articles, the corporation shall not carry on any activities not permitted to be carried on (I) by a corporation exempt from federal income tax as an organization described by Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (II) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE V BOARD OF DIRECTORS

5.01 Governance

The corporation shall be governed by its board of directors.

5.02 Directors
