ARTICLES OF INCORPORATION

OF

The undersigned incorporator to these articles of incorporation ("Articles") hereby forms a corporation not for profit ("Corporation") under the laws of the State of Florida as follows:

Article I. Name

The name of the Corporation is Miss Christian, Inc.

Article II. Address

The street address of the Corporation's principal office is: 27457 Mistflower Dr.

Article III. Purpose

The Corporation was organized and shall be operated as a tax-exempt organization exclusively for charitable, educational, and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or any of its successor laws ("Code") and relevant provisions of chapter 617, Florida Statutes. More specifically, the Corporation's purpose includes:

A Efforts to improve the lives of women in the United States of America and internationally;

A advocating for women and their voice to be heard to improve the lives of women in Florida and the local community;

A building a community of believers to have a positive impact on women and the quality of life in Florida;

A ending the exploitation of women that are victims of sexual abuse, human trafficking, oppression or unjust actions; and

A working with women and the community to promote freedom, breakthrough and unity.

Article IV. Directors

The number of directors and the manner of their appointment will be stated in the bylaws of the Corporation. The Corporation shall always have at least three directors.

Article V. Corporate Powers

The Corporation shall have all powers authorized for a corporation not for profit under the laws of the State of Florida.

Article VI. Registered Office and Registered Agent

Article VII. Incorporator
