#### <u>ARTICLE VIII</u>

Corporate Purposes: The purposes of the entity are:

- (A) The corporation is organized exclusively for charitable purposes, including providing housing, food, and monetary assistance to poor elderly people. The corporation may also provide funds to other charitable entities who qualify as exempt under section 501(c)(3) of the Internal Revenue Code or the appropriate section of any future tax code.
- (B) No part of the net earnings of the corporation shall inure to the benefit of or be distributable to any Director, Officer, or member of the corporation, or any other private individual (except that reasonable compensation may be paid for services rendered to or for the corporation, and reasonable expenses may be paid thereto, affecting one or more of the corporation's purposes), and no Director or Officer of the corporation, or any private individual shall be entitled to share in the distributions of any of the corporate asets upon dissolution of the corporation. No substantial part of the activities of the corporation shall include carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall neither participate nor intervene (including the publication or distribution of statements) in any political campaign on behalf of any candidate for purlic office, at any time.
- (C) The entity shall NOT be used for any purposes which would adversely impact its status as a section 501(c)(3) entity under the applicable provisions of the Internal Revenue Code.

#### **ARTICLE IX**
