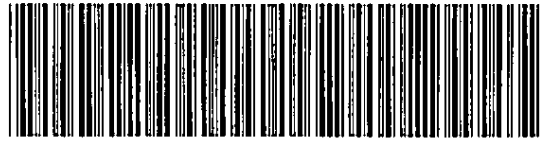

**Article I-Name**

The name of this Not-For-Profit Corporation shall be Indian River County Alumni Association, INC.

**Article II-Location**

The principal office and mailing address of Indian River County Alumni Association, INC. shall be at the following address:

Vero Beach, Florida 32960**

**Article III-Purpose**

This corporation is organized exclusively for charitable, religious, and educational purposes, including, for such purposes, for hosting any charitable event that qualifies as exempt under federal code in order to raise funds to help alumni and their family that graduated from high schools in Indian River County in the state of Florida as well as to maintain the organization itself so that it can conduct such charitable events in order to meet its mission and goals, to award scholarships to recently graduated alumni of high schools in Indian River County in the state of Florida to attend college by hosting any eligible charitable events by raising money, and for the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**Article IV-Qualifications of Directors and Initial Appointments**

The manner in which directors shall be appointed or elected will be in accordance with the by-laws and there shall always be a minimum of 3.

**Article VIII-Earnings and Activities**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the

purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**Article IX-Dissolution**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

**Article X-Effective Date**

This organization shall have an effective date of January 1, 2020 with perpetual existence unless dissolved, and at any time amendments may be adopted and approved by the board of directors in accordance with the bylaws.

Having been named as registered agent to accept service of process for the above stated corporation at the place designated in this certificate, I am familiar with and accept the appointment as registered agent and agree to act in this capacity.
