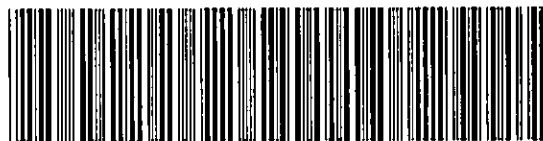

Specify the inaccuracy, incorrect statement, or defect:

On 10/28/2019, the Florida Division of Corporations processed and filed the Articles of Incorporation for INDIAN RIVER COUNTY ALUMNI ASSOCIATION, INC.. However, after further checking the detail page I noticed two clerical errors. The detail page does not list James Faber as the Chief Operating Officer, Chief Financial Officer, and Secretary of the corporation. The second clerical error was that the effective date of January 1, 2020 was missing. Instead, the only date was the filing date of 10/28/2019. Clearly, the articles of incorporations states James Faber as an officer of the corporation besides a director of the corporation as well as an effective date.

Correct the inaccuracy, incorrect statement, or defect:

I would like both of these two clerical errors to be fixed. I want you to add me (James Faber) as the Chief Operating Officer, the Chief Financial Officer, and the Secretary of the articles of incorporation of INDIAN RIVER COUNTY ALUMNI ASSOCIATION, INC. to the detail page, as it is clearly stated in Article V--Officers.

I would also like you to add the effective date of January 1, 2020 to the detail page, as the effective date is clearly mentioned in Article X--Effective Date.
