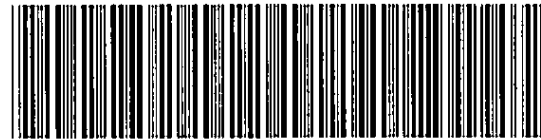

In Compliance pursuant to section 617.1006 Florida Statutes, (Not for Profit)

We, the undersigned natural person of the age of eighteen (18) years or more, acting as Incorporators of a corporation/organization under the State of Florida Non-Profit Corporation Act, do hereby register the following Articles of Incorporation as follow:

### **ARTICLE I NAME OF THE CORPORATION NON-PROFIT IS:**

### **ARTICLE III PURPOSE**

The specific purpose for which the Corporation/Organization is organized is:

- A. Said organization is organized exclusively for as a Church, Religious, Educational and Charitable Purpose, including for such purposes the making of distributions to organizations that qualify as exempt organizations under section 501 (c ) (3) of the Internal Revenue Code, or Corresponding action of any future federal tax code.
- B. No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and make payments and distributions in furtherance of the purposes set forth in the purpose clause. The organization shall not carry on any provisions of this document, the organization should not carry on any organization exempt from federal income tax under section 501 ( c ) (3) of the Internal Revenue Code or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code and corresponding section of the State of Florida Non-Profit Corporations/Organizations.

C. Upon dissolution of the Corporation/Organization or the winding up of its affairs, the assets of the Corporation/Organization shall be distributed exclusively to other Non-Profit or Charitable organizations which would then qualify under the provisions of Section 501© (3) of the Internal Revenue Code and its regulations as they now exist or as they hereafter be amended.

D . The Corporation/Organization is organized pursuant of the Florida Non-Profit Corporation Act and does not contemplate pecuniary gain or profit and is organized for nonprofit purposes.






