**ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION OF  
FLAMINGO CROSSINGS HOTELS LAND CONDOMINIUM ASSOCIATION, INC.**

THE UNDERSIGNED, Richard D. DeMarco, the incorporator of FLAMINGO CROSSINGS HOTELS LAND CONDOMINIUM ASSOCIATION, INC., a Florida Not-for-Profit corporation (the "Association"), for and on behalf of the Association, hereby executes these Articles of Amendment to the Articles of Incorporation of the Association:

**ARTICLE FIRST:** The name of the Association is FLAMINGO CROSSINGS HOTELS LAND CONDOMINIUM ASSOCIATION, INC., and the Association's Florida document number is N19000011908.

**ARTICLE SECOND:** ARTICLE I. of the current Articles of Incorporation is hereby deleted in its entirety and restated as follows:

**"ARTICLE I.  
NAME**

The name of the corporation shall be FC HOTELS LAND CONDOMINIUM ASSOCIATION, INC., a Florida Not-for-Profit corporation."

**ARTICLE THIRD:** The foregoing amendments to the Articles of Incorporation of the Association reflected herein were unanimously adopted by the Board of Directors of the Association by Written Action executed on the 25th day of November, 2019. The Association has no Members.

**ARTICLE FOURTH:** The effective date of these Articles of Amendment shall be upon the filing thereof with the Florida Department of State.
