EXHIBIT "A" TO NOT FOR PROFIT ARTICLES OF INCORPORATION HANDS OF HOPE AMERICA, INC.

ARTICLE III --- PURPOSE:

The purpose for which this corporation is organized shall be the transacting of any or all lawful business for which corporations may be incorporated under the Florida Not for Profit Corporation Act and to distribute the whole or any part of the income therefrom and the principal thereof exclusively for charitable, scientific, religious, literary, or educational purposes, either directly or by contribution to organizations that qualify as exempt organizations under Section 501 (c)(3) of the Internal Revenue Code of 1986, as amended (or the corresponding provision of any future United States Internal Revenue). However, nothing herein shall be construed as allowing any activities which would jeopardize the Corporation's tax-exempt status or otherwise be inconsistent with its classification as an organization described in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (or the corresponding provision of any future United States Internal Revenue Law).
