

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF LEADINGAGE FLORIDA, INC.

The Articles of Incorporation of **LEADINGAGE FLORIDA**, **INC.**, are hereby amended by these Articles of Amendment to Articles of Incorporation of **LEADINGAGE FLORIDA**, **INC.**, as follows:

- 1. The name of this corporation is **LEADINGAGE FLORIDA**, **INC.**
- 2. The Articles of Incorporation are amended as follows:
 - (a) Article III PURPOSE is deleted in its entirety and replaced by the following:

The purpose for which the corporation is organized is to coordinate and promote the activities and programs of retirement housing, assisted living facilities, nursing home communities, and home and community-based service providers in Florida and other states; to act as a clearinghouse for information about their programs and services; to develop progressive and effective methods of serving residents of LEADINGAGE FLORIDA, INC.'s member communities; and to work for the enactment of laws to advance the common interests of its members.

- (b) Article IV INITIAL OFFICERS AND/OR DIRECTORS is hereby deleted.
- 3. In all other respects the current Articles of Incorporation are hereby ratified and remain unchanged.
- 4. These Articles of Amendment were duly adopted and approved by a majority of the Board of Directors and a two thirds majority vote of Members of LEADINGAGE FLORIDA, INC., in accordance with the bylaws on May 5, 2023.
