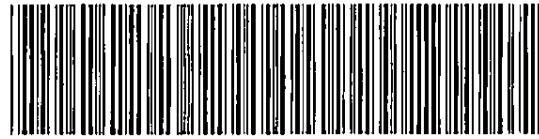

The undersigned acting as incorporators of a corporation pursuant to Florida Corporations Statute 617, adopts the following Articles of Incorporation.

ARTICLE I
NAME

The name of the corporation shall be:

ARTICLE II

ARTICLE III
PURPOSES

1. To compete in the national and international competitive youth sports arena.
2. To serve primarily economic and socially disadvantaged youth and their families.
3. To compete in any legal business necessary to the successful achievement of organizational goals and objectives.
4. To operate exclusively for charitable, religious, and educational purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986 or any corresponding of any future United States Internal Revenue Law.

ARTICLE IV
DISSOLUTION

Upon dissolution of the corporation either as an act of law or by resolution of the Board of Directors assets of the corporation shall be distributed to a non-profit 501 (c) (3) corporation. "However" if the named recipient is not in existence as a distributee, or is unwilling to accept the distribution, the assets shall be distributed to a fund, or foundation, or organization which operates exclusively for purposes specified in section 501 (c) (3) of the Internal Revenue Code of 1986 or any corresponding provision of any future Internal Revenue Law.

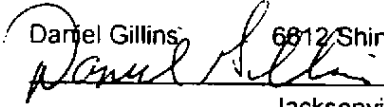

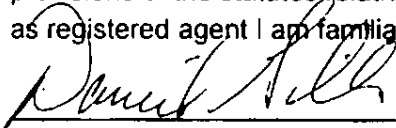
