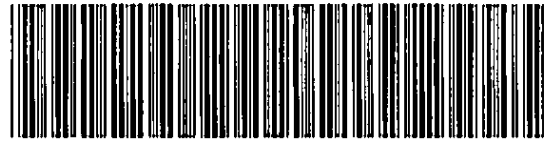

ARTICLES OF INCORPORATION
OF
PRIESTS OF THE POOR, INC.

The undersigned incorporator to these Articles of Incorporation hereby executes said Articles of Incorporation for the purpose of forming a Not For Profit Corporation under the Florida Not For Profit Corporation Act, Chapter 617 of the Florida Statutes.

ARTICLE 1. NAME AND ADDRESS

The name of the corporation and the street address of the initial principal office are PRIESTS OF THE POOR, INC., 1175 Salt Marsh Circle, Ponte Vedra Beach, Florida 32082. The mailing address of the corporation shall be 130 Corridor Road, Box 2234, Ponte Vedra Beach, Florida 32004-9998.

ARTICLE 2. DURATION

This corporation is to exist perpetually.

ARTICLE 3. PURPOSE

This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, with the specific purpose of establishing and supporting a Catholic Order of Priests whose sole mission is to serve the poor and destitute.

ARTICLE 4. INITIAL REGISTERED OFFICE AND AGENT

corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.


ARTICLE 8. MISCELLANEOUS PROVISIONS

(1) No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or directors, except that the corporation shall be empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 3.

(2) No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

(3) Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.


