

ARTICLES OF INCORPORATION
OF
PERPETUAL LIFE, INC.

ARTICLE I NAME

The name of the corporation shall be Perpetual Life, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 5128B North Florida Avenue, Tampa, Florida 33603.

ARTICLE III PURPOSE

The corporation is organized exclusively for the purpose of the disposal of bodies by burial or cremation and the corporation shall not engage in any business not necessarily incident to that purpose. The corporation shall not be operated for profit.

ARTICLE IV MEMBERS

The corporation shall not have Members.

ARTICLE V MANNER OF ELECTION OF DIRECTORS

ARTICLE VI PROHIBITED ACTIVITIES

The corporation shall not:

A. Attempt to influence legislation as a substantial part of its activities;

B. Allow any part of its net earnings, income or assets to inure to the benefit of any private shareholder or individual;

C. Participate to any extent in any political campaign for or against any candidate for public office; or

D. Conduct any activities not permitted to be carried on by organizations exempt under Section 501(c)(13) of the Internal Revenue Code of 1986, as amended, and its regulations as they now exist or as they may hereafter be amended.

ARTICLE VII DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(13) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government or to a state or local government, for a public purpose.


