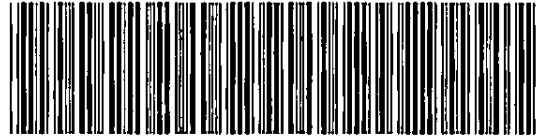

## ARTICLES OF INCORPORATION

### Article I Name

The name of the corporation shall be First Light Foundation, Inc

### Article II Principal Office

### Article III Purpose

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distribution to organizations that qualify as exempt organizations under section 501(C)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The foundation will support individuals in the area that are in desperate need of medical needs, financial needs, or homeless families as a result of a natural disaster such as fire or hurricane. We are located on the southeast coast of Florida and are considered the sailfish capital of the world. People come from all over the United States and the world to fish here and the foundation intends to raise funds by prompting fishing tournaments and other activities to raise donations to assist the individuals identified as in desperate need of assistance.

#### **Article VI Limitations**

No part of the net revenues of the corporation shall inure to the benefit of, or be distributed to its members, directors, officers, or other private individuals, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III above.

No part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

Notwithstanding any other provision of these article, this corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(C)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation contributions to which are deductible under section 170(C)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### **Article VII Dedication of Assets**

Upon the dissolution, termination, or winding up of the corporation, all assets shall be distributed for one or more exempt purposes within the meaning of section 501(C)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.


