The undersigned, acting as incorporator of a corporation under Chapter 617 of the Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation is Miami Freedom Project, Inc. (the "Corporation").

ARTICLE II: PRINCIPAL AND MAILING ADDRESS

The principal address of the corporation, located in Miami-Dade County, is 937 NW 3rd Avenue, Miami, FL 33136. The mailing address of the corporation is 937 NW 3rd Avenue, Miami, FL 33136.

ARTICLE III: PURPOSE

The purposes for which this corporation is formed are exclusively to promote social welfare within the meaning of § 501(c)(4) of the Internal Revenue Code, as may be amended, and consist of, but are not limited to, transforming Miami's political culture by using educational outreach, communication strategies, and movement building to engage in politically and culturally relevant discussions within our community to bring about a more just and equitable city.

The Corporation is not organized for profit and no part of the net earnings of this corporation shall inure to the benefit of any member of the Board of Directors or any other individual except that this corporation may make payments of reasonable compensation for services rendered.

The Corporation shall not participate or intervene directly or indirectly in any political campaign on behalf of, or in opposition to, any candidate for public office to an extent that would disqualify it from tax exemption under section 501(c)(4). The Corporation shall never be operated for the primary purpose of carrying on a trade or business for profit.

The Corporation shall use its funds only to accomplish the purposes stated in these Articles of Incorporation. Upon winding up and dissolution of the Corporation, the assets of the Corporation remaining after payment of all debts and liabilities shall be distributed to, and only to, one or more organizations recognized as exempt under either section § 501(c)(3) or § 501(c)(4) of the Internal Revenue Code.

This Corporation may do any and all lawful activities which may be necessary, useful, or desirable for the furtherance, accomplishment, fostering, or attaining of the foregoing purposes, either directly or indirectly, and either alone or in conjunction or cooperation with others, whether such others be persons or organizations of any kind or nature, such as corporations, firms, associations, trusts, institutions, foundations, or governmental bureaus, departments, or agencies.

Notwithstanding any provision of these Articles of Incorporation, Miami Freedom Project, Inc. shall not directly or indirectly carry on any activities not permitted to be carried on by an organization exempt from federal income tax under section 501(c)(4).

ARTICLE IV: MANNER OF ELECTION

The method of election of the Board of Directors shall be stated in the bylaws.

ARTICLE V: MEMBERSHIP

The qualification for members, if any, and the manner of their admission shall be stated in the bylaws.
