

Attachment to the Articles of Incorporation of Yeshiva Ohr Amram Rabbinical College Inc Article III Purpose (continued)

First, the Rabbi of the synagogue will approve the course material taught.

Second, the Directors of the synagogue will have the right to appoint directors pursuant to the approval of the seminary's dean. The initial directors have been appointed by the directors of the synagogue.

Third, the directors of the synagogue will have the right to inspect the financial records of the seminary.

Yeshiva Ohr Amram Rabbinical College Inc will operate and teach according the the laws, tenets and traditions of Orthodox Judaism and according to the practices, concepts and traditions of the Chabad Chasidic Movement --all this as understood by its dean and incorporator, Rabbi Shai Amar, who will serve as the spiritual authority of the seminary. He has been appointed according to Jewish law and he will have the authority over all matters pertaining to Jewish law, spirituality and ethics, including the sole prerogative to determine which matters pertain to Jewish law, spirituality and ethics and require his decision.

Yeshiva Ohr Amram Rabbinical College Inc is empowered to supply all the foods, religious items and physical constructions/properties that are deemed necessary by the dean or its directors for the practical accomplishment of its purpose, as well as those required according to Orthodox Jewish law or Chabad Chasidic traditions. These include, but are not limited to, religious articles, kosher food, educational materials, or transportation to any event or location which in the view of the dean or its directors is required for the fulfillment of religious duties as understood in Jewish law and tradition. It is empowered to charge a price to cover the costs, time and expenses of making such religious resources available.

Attachment to the Articles of Incorporation of Yeshiva Ohr Amram Rabbinical College Inc Article III Purpose (continued)

Yeshiva Ohr Amram Rabbinical College Inc is empowered to issue any certificates, diplomas or ordinations deemed fitting by its dean and directors pursuant to the relevant state or federal laws. The dean and the directors will authorize and bestow all certificates, diplomas or ordinations to its graduates.

Yeshiva Ohr Amram Rabbinical College Inc is organized exclusively for religious and charitable purposes and it will conduct it's activities in keeping with the letter and spirit of the IRS guidelines for a not for profit corporation. It will not distribute dividends to any of its directors or officers. It will not attempt to influence legislation in any way or participate in political campaigns of any sort. In the event of this corporation's dissolution, this corporation's directors will, after paying all debts and liabilities, convey all remaining assets to Chabad of Golden Beach Inc, its controlling synagogue, which is recognized by the Internal Revenue Service according to Section 501(c) (3). In the event that this is not feasible, the directors will distribute any remaining assets to other charitable organizations recognized by the Internal Revenue Service according to Section 501(c)(3), that have similar purposes.
