

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION



OF WEATHERSFIELD COMMUNITY ASSOCIATION, INC.

Pursuant to the provisions of Chapter 617 of the Florida Statutes, the undersigned hereby declares the following amendment (the "Amendment") was adopted to the Articles of Incorporation of **WEATHERSFIELD COMMUNITY ASSOCIATION, INC.**, a Florida Not for Profit Corporation ("the Corporation") originally filed with the Secretary of State, State of Florida on January 29, 1987:

1. <u>Amendment</u>. Article XI of the Corporation's Articles of Incorporation are hereby amended so as to read, after Amendment, as follows:

ARTICLE XI

The Association may initiate and complete a Dissolution:

- A. <u>Initiate Corporate Action</u>. The Members of the Association need to vote to dissolve the Association and transfer its assets by a two-thirds (2/3) vote at a duly called meeting, either in person or by proxy.
- B. <u>Stormwater Management System</u>. Any systems or facilities related to Stormwater Management or Discharge shall be given to an appropriate corporate entity. The appropriate entity shall provide a written confirmation of compliance with the appropriate Florida administrative code for transfer.
- C. <u>Plan of Dissolution</u>. The Board of Directors must identify all assets. Once identified, the assets must be accepted by an appropriate corporate entity in writing. Any bank accounts or funds must be accepted by a multi-party agreement of the members and the corporate entities the funds are transferring to. Any remaining liabilities need to be identified.
- D. <u>Articles of Dissolution and the Rules of Dissolution</u>. The Association must file Articles of Dissolution with the Department of State's Division of Corporations (DOC).
- E. <u>Authority Upon Formal Dissolution</u>. After the Association votes to dissolve, the Association may vote to revoke the dissolution within one-hundred-twenty (120) days. The Board may also vote to extend additional twenty (20) day periods as necessary.
- F. Notice to Creditors and Other Claimants. The Association shall identify all known creditors or claimants and provide proper notification. It must also notify all unknown creditors or claimants.

- G. <u>Filing Tax Forms</u>. The Association must file the appropriate forms with the IRS or any other relevant tax agencies, using an appropriate tax professional.
- H. <u>Distribution of Remaining Assets, After Taxes and Creditors.</u> All remaining assets shall be distributed, until no remaining assets, tax issues, or administrative regulatory issues exist. All distributed assets shall be signed over to a corporate entity, with a written confirmation letter. If any plan involves sharing of assets, that agreement needs to be in writing.


