## ARTICLES OF AMENDMENT OF

THE GREATER FORT LAUDERDALE CHAMBER FOUNDATION, I

99 FEB-2 PM 4-16

a Florida Not For Profit corporation

Pursuant to the provisions of Section 617.1006 of the Florida Not for Profit Corporation Act, the undersigned, Henry H. Fox, Chair The Greater Fort Lauderdale Chamber Foundation, Inc., a corporation organized and existing under the laws of the State of Florida (the "Corporation"), originally incorporated by Articles of Incorporation filed with the Department of State of the State of Florida on February 3, 1987, and amended on June 19, 1996, DOES HEREBY CERTIFY:

- 1. The name of this corporation is Greater Fort Lauderdale Chamber Foundation, Inc.
- 2. Section 2(c) of Article VI of the Articles of Incorporation of the Corporation is hereby amended to read as follows:

#### "ARTICLE VI

### **MANAGEMENT**

## Section 2. Board of Directors.

- (c) <u>Size</u>. The Board of Directors shall consist of no less than three (3) voting members or such higher number as may be provided in the Bylaws."
- 3. The foregoing amendment was adopted by the voting member and all of the Directors of the Corporation eligible to vote by a Written Consent signed by them as of the 18th day of December, 1998, manifesting their intention that these amendments to the Articles of Incorporation be adopted.
- 4. There is only one voting group entitled to vote on the foregoing amendment. The number of votes cast for said amendment by said voting group was sufficient for approval by that voting group.

IN WITNESS WHEREOF, the undersigned, as Chair of the Corporation, has executed these Articles of Amendment this 187 day of 1998.
