ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION OF VISITING NURSE FOUNDATION OF PALM BEACH COUNTY, INC.

- 1. The following provisions of the Articles of Incorporation of VISITING NURSE FOUNDATION OF PALM BEACH COUNTY, INC., a Florida not for profit corporation, filed with the Department of State on February 10, 1987, be and they hereby are amended in the following particulars:
 - A. The last paragraph of ARTICLE III shall read as follows:

"Subject to the foregoing, assets of this Corporation shall be distributable only to such Florida not for profit corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, as the Board of Directors of this Corporation may designate."

B. ARTICLE IV shall read as follows:

"The Members of this Corporation shall be those persons who are members of the Board of Directors hereof."

C. ARTICLE VIII shall read as follows:

"In the event of dissolution, any residual assets of this Corporation will be distributed for one or more exempt purpose of purposes specified in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or corresponding sections of any future Internal Revenue Law of the United States, or to the Federal, or a State, or Local government for exclusively public purposes. Subject to the foregoing, in the event of dissolution, any residual assets of this Corporation will be distributed to such Florida not for profit corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, as shall be designated by the Board of Directors of this Corporation prior to its dissolution."

2. The foregoing amendments were adopted by the sole Member of the Corporation and by the Board of Directors of the Corporation on the 31st day of December, 1997.
