ARTICLES OF INCORPORATION
OF
THE JOSEPH L. MORSE GERIATRIC CENTER, INC.

In accordance with Chapter 617, Florida Statutes, the undersigned, acting as incorporator of a corporation under the Florida Not For Profit Corporation Act, hereby adopts the following Articles of Incorporation for such Corporation.

ARTICLE I

Name of Corporation

The name of this Corporation shall be THE JOSEPH L. MORSE GERIATRIC CENTER, INC.

ARTICLE II

Purposes

The purposes for which this Corporation are organized are exclusively charitable, scientific, and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986.

ARTICLE III

Prohibited Activities

No part of the net earnings of this Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that this Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article II hereof.

No substantial part of the activities of this Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and this Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these Articles, this Corporation shall not carry on any other activities not permitted to be carried on by (a) a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provisions of any future United States Internal Revenue Law or (b) a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986, or any other corresponding provisions of any future United States Internal Revenue Law.

ARTICLE IV

Membership

The sole member of this Corporation shall be the Jewish Home for the Aged of Palm Beach County, Inc., or its successors.

ARTICLE V

Corporate Duration

This Corporation shall have perpetual existence unless sooner dissolved by law.

ARTICLE VI

Initial Registered Office and Agent

The street address of the initial registered office of this Corporation is 4847 Fred Gladstone Memorial Drive, West Palm Beach, Florida, and the name of the initial registered agent of this Corporation at such address is E. DREW GACKENHEIMER.

ARTICLE VII

Board of Directors

Section 1. Number. This Corporation shall have three (3) Directors initially. The number of Directors may be either increased or diminished from time to time in accordance with the Bylaws, but shall never be less than three (3).

Section 2. Initial Board. The names and addresses of the initial Directors of this Corporation, who shall serve until their successors are elected or appointed and have qualified, are:

Section 3. Election. Directors shall be elected in accordance with the Bylaws of this Corporation.

ARTICLE VIII

Dissolution

In the event of dissolution, any residual assets of this Corporation will be distributed for one or more exempt purpose or purposes specified in Section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding sections of any future Internal Revenue Law of the United States, or to the Federal, or a State, or Local government for exclusively public purposes. Subject to the foregoing, in the event of dissolution, any residual assets of this corporation will be distributed to the Jewish Home for the Aged of Palm Beach County, Inc., a Florida corporation not for profit, or any designee or successor corporation thereof.

ARTICLE IX

Officers

Section 1. The affairs of this Corporation shall be managed by a President, a Secretary and a Treasurer and such other additional officers as may be provided by the Bylaws.

Section 2. The officers shall serve as set forth in the Bylaws of the Corporation.

Section 3. The names and addresses of the first officers of this Corporation who shall serve until such time as they resign, are removed, or their successors are elected, appointed and have qualified are:

ARTICLE X

Bylaws

The Bylaws of this Corporation shall be made, altered, amended or rescinded at any regular or special meeting of the Board of Directors of this Corporation by the affirmative vote of two-thirds (2/3) of the Directors present at any such meeting.

ARTICLE XI

Indemnification

Every Director and every officer of the Corporation shall be indemnified by this Corporation to the full extent permitted by law against all expenses and liabilities, including attorney's fees in trial and appellate proceedings or any settlement thereof, reasonably incurred by or imposed upon him in connection with any proceeding to which he may be a party, or in which he may become involved, by reason of his being or having been a Director or officer of this Corporation, whether or not he is a Director or officer at the time such expenses are incurred, unless the liability of the Director or officer in question is adjudged by decision of court to result from the gross negligence or willful misconduct of such officer or Director in the performance of his duties; provided, however, that in the event of a settlement, the indemnification herein shall apply only when the Board of Directors approves such settlement and reimbursement as being in the best interest of this Corporation. The foregoing right of indemnification shall be in addition to and shall not be exclusive of all other rights to which said Director or officer may be entitled.
