

ARTICLES OF INCORPORATION OF

National Foundation for Piano Conservation, Inc. A FLORIDA NONPROFIT CORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE LNAME

The name of the corporation shall be: National Foundation for Piano Conservation, Inc.

ARTICLE IL PRINCIPAL OFFICE
