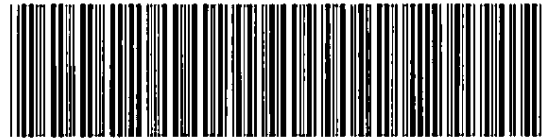

Article III of the Articles of Incorporation should be amended to read as follows:

ARTICLE III

The specific purpose for which this corporation is organized is:

(1) To operate exclusively for charitable and educational purposes within the meaning of Section or 501(c)(3) of the Internal Revenue Code of 1954, as amended (hereinafter the "Code"); (2) To raise funds for the purposes of the Corporation's function; (3) To provide assistance to economically challenged communities, families, and at-risk youth.

Upon the dissolution of the Corporation, whether voluntary or involuntary, the assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose.
