# ARTICLES OF INCORPORATION OF SPARTANS YOUTH BASKETBALL, INC. (A CORPORATION NOT FOR PROFIT)

The undersigned acknowledges and files in the office of the Secretary of State of Florida, for the purposes of forming a corporation not for profit in accordance with the laws of the State of Florida, these Articles of Incorporation.

#### ARTICLE I NAME

The name of the corporation is Spartans Youth Basketball, Inc.

### ARTICLE II PRINCIPAL OFFICE AND ADDRESS

The address of the principal office of the corporation 1102 South Florida Avenue, Suite 111, Lakeland, Florida 33803, and the mailing address is the same.

### ARTICLE III PURPOSE

The corporation is organized exclusively for charitable, religious, educational, or scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, as amended, and to do any other act or thing incidental to or connected with the foregoing purposes or in advancement thereof.
