## ARTICLES OF INCORPORATIONS OF CHILDREN ORGANIZATIONS FOR STO. NIÑO INTERNATIONAL FOUNDATION, INC.

(A non-profit Corporation)

#### **ARTICLE I**

#### **CORPORATE NAME**

The Name of the Corporation shall be CHILDREN ORGANIZATIONS FOR STO. NIÑO INTERNATIONAL FOUNDATION, INC.

#### ARTICLE II

#### PRINCIPAL OFFICE

Principal office is 4100 Corporate Square Center, Suite 101, Naples, Florida 34104

#### **ARTICLE III**

#### GENERAL PURPOSE

To improve the lives of abandoned orphan children in a socially and emotionally deprived environment. Extend potential assistance of their developmental needs. Raise them, in a safe place to live and to be supported in their educational and life-skills pursuits. To help them achieve their dreams for themselves, for their communities and nations worldwide, and keep them from vulnerable exploitation resulting to high level of criminality and other adverse outcomes re-enforcing the cycle of poverty.

This Corporation is being organized as a corporation defined in Section 501(c) (3) of the Internal Revenue Code of 1986, as amended (the "Code"), or the corresponding section of any future federal tax code and shall be organized and operated exclusively for charitable, religious, educational and scientific purposes, provided, however, that the Corporation shall not engage in activities that are not in furtherance of its charitable purposes other than as an insubstantial part of its activities.

#### **ARTICLE IV**

#### **ACTIVITIES NOT PERMITTED**

Notwithstanding any other provision of these Articles, the Corporation will not carry on any other activities not permitted to be carried on by a corporation exempt from Federal income tax under Section 501(c) (3) of the code or the corresponding provision of any future United States Internal Revenue Law.

#### **ARTICLE VII**

#### DEDICATION AND DISTRIBUTION OF ASSETS

No parts of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, any director or officer of the corporation or any private individual (except that reasonable compensation may be paid for services rendered affecting one or more of its purposes) and no director or officer of the Corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets upon dissolution of the Corporation. No substantial part of the activities of the Corporation shall be carrying on propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition candidate for public office. Notwithstanding any other provision of these Articles, this Corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this Corporation. In the event of dissolution of the Corporation or the winding up of its affairs, or other liquidation of its assets, the Corporation's property shall be conveyed or distributed to such other Florida not-for-profit corporations operated for nonprofit purposes similar to those of the Corporation which at the time of such conveyance or distribution qualify as an exempt organization under Section 501(c) (3). Any such assets not so disposed of shall be distributed by the appropriate Court of the jurisdiction in

which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or as said court shall determine which are organized and operated for such purposes.

#### **ARTICLE VIII**

#### INDEMNIFICATION

Every person who now is hereafter shall be a Director or Officer of the Corporation shall be indemnified by the Corporation against all costs and expenses (including counsel fees) hereafter reasonably incurred by or imposed upon him/her in connection with, or resulting from any action, suit or proceedings of whatever nature, to which he/she is or shall be made a party by reason of his/her being or having been a Director of Officer of the Corporation (whether or not he/she is a Director or Officer of the Corporation at the time he/she is made party to such action, suit or proceeding, or at the time such cost or expense is incurred by or imposed upon him/her) except in relation to matters as to which he/she shall be finally adjudged in such action, suit or proceeding to have been derelict in the performance of his/her duties as such Director or Officer. The Right of indemnification herein provided shall not be exclusive of other rights to which any such person may now or hereafter be entitled to as a matter of law.

The Board of Directors and the Executive Board of Directors of the Corporation may provide such bylaws for the conduct of the business of the Corporation and the carrying out of its purposes as such Directors may deem necessary from time to time.
