The specific purpose for which this corporation is organized is to provide financial support by awarding scholarships to minority college students who excel academically, athletically, and who demonstrate strong involvement in their local church and/or community.

The Family of Faith Scholarship Fund, Inc. is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations described under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the Family of Faith Scholarship Fund, Inc., assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
