**ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION OF  
CODING ANGEL, INC.**

Pursuant to the provisions of Section 617.1006, Florida Statutes, CODING ANGEL, INC., a Florida not-for-profit corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation which were filed with the Florida Department of State on January 21, 2020, Charter Number N20000000528.

**FIRST:** Article IV, Section 4 of the Articles of Incorporation of the Corporation is amended in its entirety to read as follows:

**Article IV
