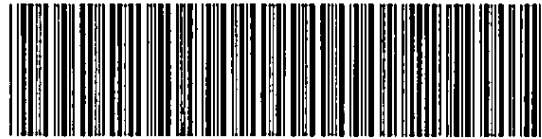

Article I

The name of this corporation shall be TCTeam Charities Inc and the period of duration is perpetual.

Article II

The principal office located at 323 St. Johns Avenue; Palatka, Florida which will also serve as the mailing address.

Article III

TCTeam Charities is a non-profit corporation and shall be operated exclusively for charitable purpose within the meaning of Section 501c(3) of the Internal Revenue Code or the corresponding section of any future Federal Tax Code. TCTeam Charities Inc purpose is to focus on the basic needs of our local community by financially supporting charities which serve Putnam County Citizens to enhance the quality of life in our community.

Article IV

The Election of the Board of Directors will occur once a year at the Annual Board meeting in October of each year by a majority vote of the current directors.

Article V

Upon termination or dissolution of the TCTeam Charities Inc any assets lawfully available for distribution shall be distributed to one or more qualifying organizations described in Section 501c(3) of the Internal Revenue Code which organization(s) have a charitable purpose which, at least generally, includes a purpose similar to the purpose of the TCTeam Charities Inc.

The TCTeam Charities shall be governed by its Board of Directors; the initial directors are as follows:




