This corporation is established exclusively for charitable purposes within the meaning of Section 501(c)(3) of the IRS Code, namely: to aid the poor, distressed, or underprivileged populations-- including families, children and the elderly-- who are located in the State of Florida or elsewhere in the US. It will establish and maintain a network of grass roots organizations and activists who will identify community needs and assist the needy receiving the services which they deserve. It will advocate for the delivery of services as required by law and according to best practices. It will plan and implement supplementary education programs for children, youth and adults. In all its activities, it will strive to defend human and civil rights as secured by law, combat community deterioration and prevent juvenile delinquency.

This corporation will foster the empowerment of the underprivileged by forging partnerships with local resource providers, and by insuring that the full range of available benefits are provided to all who need them. It will strive to educate and counsel disadvantaged families or individuals concerning how to obtain affordable housing. When necessary, it will undertake the construction, renovation or rehabilitation of substandard housing in order to provide decent, safe, and sanitary homes to low and moderate income families. In instances of severe difficulties -- and at the sole discretion of the directors and the president-- this corporation is empowered to make direct cash grants to avert crises and prevent continued deterioration of families, individuals or children. This corporation is empowered to provide funding to other charitable organizations when such organizations are better equipped to carry out some of the purposes of this corporation. At such times the officers and directors will be responsible for verifying that the funds provided have been used to further the work of this corporation.

This corporation will conduct its activities in keeping with the letter and spirit of the IRS guidelines for a not for profit corporation. It will not distribute dividends to any of its directors or officers. It will not attempt to influence legislation in any way or participate in political campaigns of any sort. In the event of the dissolution of this corporation, the directors will --after clearing all debts and liabilities-- distribute all remaining assets to other charitable corporations recognized as such by the IRS under section 501(c)(3) and that have similar goals.
