AMENDED AND RESTATED ARTICLES OF INCORPORATION OF 3811 DRAINAGE AND IMPROVEMENT ASSOCIATION, INC.

(A FLORIDA NOT FOR PROFIT CORPORATION)

We, the undersigned, hereby subscribe to and adopt the following as our Amended and Restated Articles of Incorporation (the "Articles") under the laws of the State of Florida:

ARTICLE I.

The name of this corporation is 3811 DRAINAGE AND IMPROVEMENT ASSOCIATION, INC., a Florida not for profit corporation (the "Association"). The initial principal office of the Association is 2823 Ryan Blvd., Punta Gorda, FL 33950, and the initial mailing address of the Corporation is 2823 Ryan Blvd., Punta Gorda, FL 33950.

ARTICLE II.

This Association is organized to act as the governing association for the management and maintenance of the stormwater management system for certain commercial property located in Charlotte County, Florida (the "System").

ARTICLE III.

The terms used in these Articles shall have the same definitions and meanings as those set forth in the Declaration of Covenants, Conditions, and Restrictions for 3811 Drainage and Improvement Association, Inc., a Florida not for profit corporation (the "Declaration")

ARTICLE IV.

The qualification of members and the manner of their admission shall be as follows: The owner of any portion of the Property subject to the Declaration shall, by virtue of such ownership, be a member of this Corporation.

ARTICLE V.

These Articles shall become effective upon filing with the Secretary of State, Tallahassee, Florida. These Articles fully amend and restate the Articles of Incorporation originally filed on January 28, 2020. The Association shall exist in perpetuity.

In the event of termination, dissolution or final liquidation of the Association, the

responsibility for the operation, control and maintenance of the System together with any easement or other rights of access shall be transferred to and accepted by an entity which complies with Rule 62-330.310, of the Florida Administrative Code. Such transfer shall be subject to approval by the Southwest Florida Water Management District ("SWFWMD") prior to such termination, dissolution, or liquidation.

ARTICLE VI.

The Association shall have all powers and duties existing under applicable provisions of the Florida Not-For-Profit Corporation Act (Chapter 617 of the Florida Statutes). Without limiting the generality of the foregoing, the Association shall have the power to do the following:

- Own and control property.
- b. Operate, maintain, and manage the System, including all inlets, ditches, swales, culverts, water control structures, retention and detention areas, ponds and any associated buffer areas in a manner consistent with the requirements of applicable permits, including, but not limited to the SWFWMD Permit No. 43009677.004 and applicable SWFWMD rules, and to assist in the enforcement of the restrictions and covenants contained herein and in the Declaration.
 - c. Establish and enforce rules and regulations.
- d. Assess its members and enforce assessments with the power to place liens on the Property subject to the Declaration. In addition to other assessments, the Association shall levy and collect adequate assessments against members of the Association for the costs of maintenance and operation of the System. These assessments shall be used for the maintenance and repair of the System, including, but not limited to work within retention areas, drainage structures and drainage easements.
 - e. Sue and be sued.
 - f. Contract for services to provide for operation and maintenance of the System.
 - g. Require all owners to be members.
- h. Take any other action necessary for the purposes for which the Association is organized.
