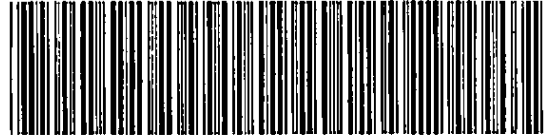



OF
BETHEL COMMUNITY CEMETERY ASSOCIATION, INC.

a Non-Profit Corporation

The undersigned, acting as incorporator of a corporation under the Florida Not For Profit Corporation Act, adopt the following articles of incorporation for such corporation.

ARTICLE I
NAME

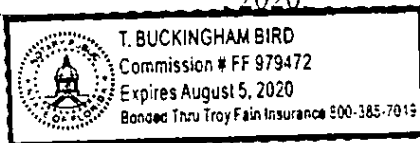


