ARTICLE 3 "PURPOSE"

3. Fostering the care of orphans and other children without families, facilitating their placement with adoptive families and thereby bringing bring hope, peace and joy to the motherless, to the heart broken and to suffering families;
4. Establishing and conducting skills acquisition centers and clusters to convey the skills necessary to succeed in any location in today's global markets;
5. Providing transformational leadership, personal development and entrepreneurial training and mentoring for youths and women in the skills needed to achieve economic independence worldwide.
6. Promoting partnership and collaboration among and between young and female entrepreneurs.
7. Sponsoring the construction of primary health care facilities to provide for the basic health care needs of underprivileged.
8. Sponsoring the construction small sports facilities to nurture the talents of the underprivileged and where their skills to be enhanced to reach the optimum level of their innate potentials
9. To carry out any action deemed by the President or the Directors to be in furtherance of well being of needy families, children or individuals in the State of Florida, the US or worldwide.

The incorporator will serve as the first President of this corporation. She will continue to serve indefinitely unless she should be found to be unable to serve or substantially unfit for her position, or in the event of her resignation. In the event of this corporation's dissolution, the Directors will --after clearing all debts and liabilities-- distribute all remaining assets to other similar corporations which are recognized by the IRS under Section 5019(c)(3) as tax exempt charities.
