



ARTICLES OF INCORPORATION

ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is Holy Family Old Catholic Church & Corporation and its principal place of business shall be located at 925 Murcott Street, Lakeland, Florida 33803.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE
