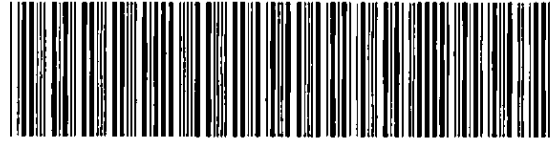


This is to submit my letter of resignation as a member of the Board of Directors of Global Health and Community Service, Inc. (Global Health).
