



ARTICLE HEPURPOSES

The purpose for which the religious organization Ministerio Misionero Un Nuevo Comienzo. En Cristo. Inc. is established is the following:

- (a) Establish a Church or Churches to promote, instruct and establish the teachings of Jesus Christ and facilitate Christian worship and fellowship among members, non-members and the general public.
- (b) Facilitate, implement and support religious missionary and evangelistic work at the local level and internationally.
- (c) Train, prepare and ordain Ministers, Missionaries, Preachers and Evangelists, Religious Workers, Bible Teachers, Deacons, Elders, Counselors, Elders and Volunteer Chaplains for Christian service and community.
- (d) Establish a local church association or convention and future branches.
- (c) Establish theological institutes, ministerial seminaries and other institutions of learning to the continuing religious education of local, national and international members and the community in general.
- (f) Our Organization has registered a Fictitious name. Iglesia Misionera Un Nuevo Comienzo En Cristo. Download documents # G23000140927 that will operate under our organization to be used for our church People's Mission Houses, Community Centers for the Poor, Drug and Alcohol Rehabilitation Centers and Youth Centers.
- (g) Use all means to communicate Christian instructions, meditation and principles to members and the general public in accordance with appropriate copyright statutes. Promote and exercise the constitutional rights of freedom of expression, religion and the press in each of the religious activities, in due form, in accordance with the law.
- (h) Notwithstanding any other provision of these articles, the organization is organized exclusively for one or more of the purposes specified in section 501(e)(3) of the Internal Revenue Code of 1986. It shall not carry out any activities is not permitted to be conducted by an organization exempt from federal income tax under IRC 501(e)(3) or the corresponding provision of any subsequent tax law.
- (i) No material part of the organization's activities will be based on propaganda, nor will it attempt to influence legislation (except as otherwise provided by IRS501(h) nor participate or intervene in (including the publication or distribution of these statements), any political campaign for or against any candidate for public office.

ARTICLE IV POWERS

Ministerio Misionero Un Nuevo Comienzo En Cristo, Inc., will and exercise all the rights and powers conferred on corporations under the laws of the State of Florida, provided that this corporation has no authority to engage in any activity other than to advance objects and purposes set forth in Article III.

ARTICLE V NO FINANCIAL PROFIT OR MONETARY GAIN

Ministerio Misionero Un Nuevo Comienzo. En Cristo, Inc., is neither organized nor operated for profit or pecuniary gain and includes distributing goods or dividends to members, as this organization is formed non-profit. The property, assets, and net earnings of this corporation are irrevocably dedicated to religious, scientific, and charitable, and any gain or net flow of this corporation shall be to the advantage or benefit of any director, officer, and member of for the benefit of private shareholders or individuals. The dissolution or closing liabilities of the corporation shall be distributed to a non-profit fund, foundation, or corporation which is organized and operated exclusively for religious, charitable, or scientific, or which has established its tax-exempt status under Section 23701 (d) of the code of Internal Revenue Taxes. If this corporation has any assets in deposits, such property shall be distributed according to the decrees of the Superior Court of the County within which the principal office of this corporation is located at the request of that attorney general or by any person interested in the settlements.

ARTICLE VI LIMITATION OF ACTIVITIES

Ministerio Misionero Un Nuevo Comienzo. En Cristo, Inc., has not conducted any propaganda as a substantial part of its activities or attempted in any way to influence the legislation. This corporation shall not participate in originaterycne in (including publishing or distributing of statements) any political campaign on behalf of any candidate for public office.

ARTICLE VII DIRECTORS / OFFICERS' MANNER OF ELECTION

The officers in charge of managing this corporation's affairs shall be as follows: President (Pastor). Secretary, Treasurer, and Deacons. Ministerio Misionero Un Nuevo Comienzo. En Cristo, Inc. shall appoint the President. The president shall hold office until otherwise directed by the above-mentioned councils. The secretary, treasurer, and deacons shall be elected by due process of general election. Candidates shall be selected from among the corporation members who qualify for election as designated by the corporation bylaws. Elections are to be held annually, and every active member of the corporation has the right to vote. The people to hold these positions have been elected by vote people majority. They shall hold office until their new successor has been elected and qualified
