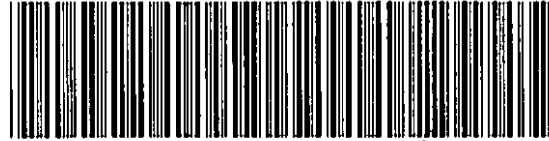

Jurisdiction of the county in which the principal officer of the Jesus Church Online Inc is then located, exclusively for such
organization or organizations, as said Court shall determine, which are organized and operated exclusively
for such purposes.
