

## ATTACHMENT TO ARTICLES OF INCORPORATION FOR MATAWONN FOR HUMANITY ARTICLE 3 "PURPOSE"

This organization will maintain to network of helping agencies, religious, organizations and social welfare organizations in order to identify such needy persons or families. It will conduct follow up investigations to verify the effectiveness of its programs. In exceptional cases -- and at the sole discretion of the directors-- it will be empowered to make direct cash grants to save needy persons or families from immediate crises. It will strive to make the world a better place and encourage universal compassion and harmony.

This corporation will conduct it's activities in keeping with the letter and spirit of the IRS guidelines for a not for profit corporation. It will not distribute dividends to any of its directors or officers. It will not attempt to influence legislation in any way or participate in political campaigns of any sort. The incorporator will serve as the first President of this corporation. He will continue to serve indefinitely unless he should be found to be unable to serve or substantially unfit for his position, or in the event of his resignation.

In the event of this corporation's dissolution, the Directors will --after clearing all debts and liabilities-- distribute all remaining assets to other similar corporations which are recognized by the IRS under Section 5019(c)(3) as tax exempt charities.
