

Articles of Incorporation (Non-Profit)

Article I: The name of the corporation shall be the Fifth Avenue Neighborhood Association, Incorporated.

Article II: The principal place of business and mailing address shall be: 616 N.W. 8th Street, Gainesville, Florida 32601 and P.O. Box 358538 Gainesville, Florida 32635-8538.

Article III: The purpose for which the corporation is organized is to advocate for the improvement of the quality of life in the historic 5th Avenue neighborhood within the City of Gainesville and within its various departments that provide city services to the neighborhood.
