- 1. **Name**. The name of the corporation is Inspired Wellness Solutions, Inc.
- Mailing Address and Principal Place of Business. The initial mailing address and principal place of business of the corporation will be:

21301 S. Tamiami Trail # 320-130 Estero, Florida 33928

- 3. Purpose and Prohibited Activities.
 - a. The purposes of the corporation are to:
 - i. Provide wellness, healing services and preventative education, to those in need of services.
 - ii. To solicit and receive gifts, grants, funds, bequests and endowments from individuals, companies and foundations;
 - To contract with other agencies, foundations, corporations and other entities to provide healing services to persons in the care of such entities;
 - To establish a healing center as a location to provide its services; and
 - v. To exercise all of the powers permitted by the Florida statutes relation to not for profit corporations, and to have all of the powers necessary for the achievement of its purposes as are not in derogation of the statutes of Florida.

- ii. The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary and educational as set forth in Section 501(c)(3) of the Internal Revenue Code of 1986 or any corresponding provision of any future law relating to internal revenue;
- iii. Notwithstanding any other provision of these articles, the corporation may not engage in any activity that is not permitted by Section 501(c)(3) of the Internal Revenue Code or any successor to that provision in any future law relating to internal revenue.
- 4. **Directors**. A board of not less than three directors will manage the affairs of the corporation. Each director will serve for a term of one year. The members of the board of directors will elect their successors and fill any vacancy, or the directors may be elected as provided from time to time in the bylaws.
