Pursuant to the provisions of Sections 617.1002 and 617.1006 of the Florida Business Corporation Act (the "FBCA"), OHI West, a Florida not for profit corporation, adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE I Name

The name of the corporation is OHI West, Inc. (the "Corporation").

ARTICLE II Amendment to the Articles of Incorporation

Article VI of the Articles of Incorporation of the Corporation is hereby deleted in its entirety and replaced to read as follows:

ARTICLE VI Management

The affairs of the Corporation are to be managed by a Board of Directors. The exact number of directors shall be the number as provided in the Bylaws of the Corporation and may be changed from time to time as provided in the Bylaws.

All directors of the Corporation shall be appointed by the Member and shall hold office for the term and possess such qualifications as are set forth in the Bylaws of the Corporation.
