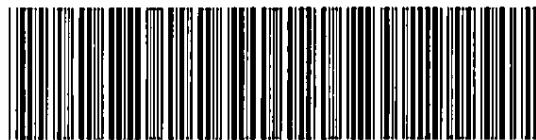


Subject: Request Name Release for The Lord's Supper Soup Kitchen, Inc.


