ARTICLES OF INCORPORATION OF EAST PASCO LEGAL SERVICES CLINIC, INC.

In compliance with the requirements of F.S. Chapter 617, the undersigned hereby oct as incorporators in adopting and filing the following articles of incorporation for the hurpose of organizing a corporation not for profit.

ARTICLE I

The name of the Corporation is: East Pasco Legal Services Clinic, Inc...

ARTICLE II

The street address of the principal office of the Corporation is: 5316 8th Street, Zephyrhills, Florida 33542.

ARTICLE III

The organization is organized exclusively for charitable, religious, educational, and scientific purposes under section 501(c)(3) of the Internal Revenue Code, or corresponding sections of any future federal tax code.

ARTICLE IV

Any subsequent directors of the corporation shall be elected or appointed in accordance with the method of election of directors stated in the corporation's bylaws.

Pursuant to F.S. 617.0824(2), the articles hereby authorize a quorum for the purpose of a meeting of the corporation's board of directors to consist of less than a majority but no fewer than one-third of the prescribed number of directors determined under the articles of incorporation or the bylaws.
