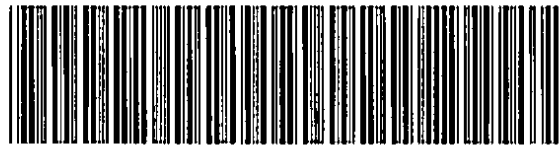

**Articles of Incorporation**  
**of**  
**"Iglesia Cristiana Ríos de Agua Viva, Inc."**

Pursuant to Chapter 617, Florida Statute (F.S.), the undersigned incorporator hereby adopts the following Articles of Incorporation for a not for profit corporation:

**Article 1— Corporate Name**

The name of this non-profit corporation is: Iglesia Cristiana Rios de Agua Viva, Inc.

**Article 2 – Initial Principal Office and Mailing Address**

**Article 3 – Purpose**

Iglesia Cristiana Rios de Agua Viva, Inc, is organized and its assets shall be used solely and exclusively for religious, charitable and educational purposes, as defined by Section 501(c)(3) of the Internal Revenue Code, as amended.

The purposes for which Iglesia Cristiana Rios de Agua Viva, Inc., is organized, are to operate and function as a church in all its religious, charitable and educational dimensions including but not limited to the following church's purposes:

- To advance and promote the worship of God.
- To engage in and promote the study of the Holy Scriptures.
- To advance the gospel of Jesus Christ by preaching, evangelism, teaching and the administration of the ordinances of the church.
- To create and sustain Christian fellowship as a nurturing and discipling function of the church.
- To promote the Biblical principles of justice and righteousness in personal, social, community, and national life.

#### **Article 6 – Registered Agent**

#### **Article 8 – Duration of Corporation**

The period of duration of this corporation is:

Iglesia Cristiana Rios de Agua Viva, Inc., shall have perpetual existence.

## **Article 9 – Dissolution**

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for religious, charitable, educational, scientific or literary purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Code as the Board of Directors shall determine, or to federal, state, or local governments to be used exclusively for public purposes. Any such assets not so disposed of shall be disposed of by the Superior Court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations, such as the court shall determine, which are organized and operated exclusively for such purposes, or to such governments for such purposes.

## **Article 10 – Prohibitions**

No part of any earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons for any reason not authorized by the Board of Directors, except that the corporation shall be authorized and empowered to pay reasonable, measurable and verifiable competitive compensation for services rendered to the corporation and to make payments and distributions in furtherance of the purposes set forth in Article 4 hereof. No substantial part of the activities of Iglesia Cristiana Ríos de Agua Viva, Inc shall be dedicated to, or otherwise attempt to influence United States State or Federal legislation, and the corporation shall not participate or intervene in any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permissible (A) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or (B) by a corporation, contributions to which are deductible under section 1: 70(c)(2) of the Internal Revenue Code.

## **Article 11 – Limitations of Liability**

An officer or director of the Corporation shall have no monetary liability for damages

in any proceeding brought by or in the right of the Corporation or brought by or on behalf of the members of the Corporation. With the exception to the extent the officer or director engaged in willful misconduct or a knowing violation of the criminal law.

### **Article 12 – Amendments**

These Articles of Incorporation may be amended at any time in the manner provided by the laws adherent to the jurisdiction of the State of Florida. Every amendment shall be approved by the Board of Directors.
