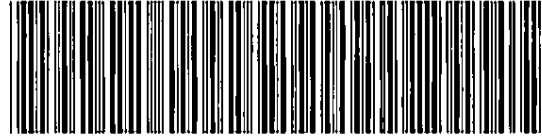

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

[2] THAT, pursuant to State Law CHAPTER 761.03 FREE EXERCISE OF RELIGION PROTECTED, FLORIDA STATUTES, and Federal Law TITLE 42 U.S.C. § 2000cc Religious Land Use and Institutionalized Persons Act of 2000 (hereafter "RLUIPA"), that ABYYAH is a divine "SEPARATION OF CHURCH AND STATE" Sovereign Kingdom of Almighty Yahweh Government (Kingdom) Religious Assembly (The Church) Entity, pursuant to the FIRST AMENDMENT, U.S. CONSTITUTION (Separation of Church and State Clause).

[3] THAT, ABYYAH, We the People, Kingdom of Yahweh, Tribe of Almighty Yahweh, Independent, Private Citizens, Sovereign Government (Kingdom) for Original Ancient African Hebrew (Jewish) Private Citizens, The lost Tribes of Almighty Yahweh African Hebrews (Black Jews), Benevolent, Divine, Sacred and Holy Religious Humanitarian mission, goal and objective, is to fulfill Almighty Yahweh's divine "GREAT COMMISSION". Cf. Mattithyah (Matthews) 28:18-20, The Book of Yahweh, The Holy Scriptures (a/k/a "The Holy Bible"), i.e.

- (1) To build Yahweh a House (Kingdom) that will bear His Divine, Sacred and Holy exclusive Name for His African Hebrew (Black Jews) "Chosen People" of The Ancient Hebrew Holy Scriptures (a/k/a "The Holy Bible")
- (2) To obey Almighty Yahweh's 613 Laws
- (3) To be Torah-observant to The Book of Yahweh exclusively
- (4) To be faithful and sincere Sabbath-Keepers
- (5) To Follow, Worship, and Praise only Almighty Yahweh, the Creator, and NOT any God/Lord/Man
- (6) To Minister, Reach-Out, Gather and Herald the divine-call to "Repent and Convert", Acts 3:19, The Book of Yahweh (a/k/a "The Holy Bible"), to Almighty Yahweh's 613 Laws, Character (image/likeness) and Way-of-Life, and
