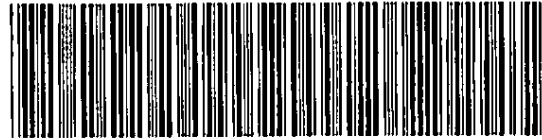

## NOT-FOR-PROFIT ARTICLES OF INCORPORATION

ARTICLE I – The NAME of the corporation shall be "A Time To Love, Inc."

ARTICLE II – The PRINCIPAL STREET OFFICE and MAILING ADDRESS of the corporation shall be:

ARTICLE III – The PURPOSE for which the corporation is organized is exclusively for charitable, religious, educational or scientific purposes under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

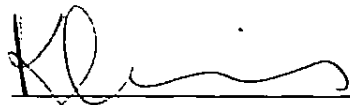

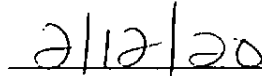
