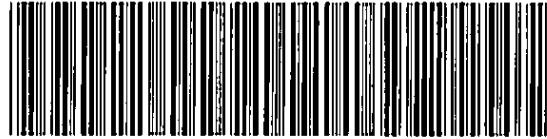

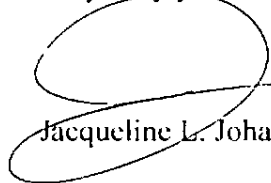

**ARTICLES OF INCORPORATION  
OF  
INDEAL CARES INC.**

**ARTICLE I  
NAME**

The name of the corporation is INDEAL Cares Inc. (hereinafter referred to as the "Corporation").

**ARTICLE II  
EFFECTIVE DATE**

The effective date of the Corporation is February 22, 2020.

**ARTICLE III  
DURATION**

The Corporation shall have perpetual existence unless it shall hereafter be dissolved according to law.

**ARTICLE IV  
REGISTERED OFFICE AND AGENT**

The Corporation's principal office is located at 259 4<sup>th</sup> Avenue North, St. Petersburg, FL 33701. The registered agent at that address is David Gatherum.

**ARTICLE V  
PURPOSES**

The purposes for which the Corporation is formed, and the business and objectives to be carried on and promoted by it, are as follows:

- A. To support and make distributions to organizations that advance the assessment and treatment of spinal conditions and those that are dedicated to advancing disease prevention, active living and mental health. The Corporation's not-for-profit initiatives may be expanded from time to time as determined by its Board of Directors.
- B. This Corporation is organized exclusively for non-profit, charitable, scientific, literary, religious, or educational purposes within the meaning of § 501(c)(3) of the Internal Revenue Code. Notwithstanding any other provision of this Certificate, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under § 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue law); or (b) by a corporation contributions to which are deductible under § 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue law).
- C. To carry out its purposes, the Corporation may exercise the powers permitted non-profit corporations under Chapter 617 of the Florida Statutes; provided, however, that this Corporation, in exercising any one or more of such powers shall do so in furtherance of the exempt purpose for which it has been organized as described in Section 501(c)(3) of the Internal Revenue Code.

**ARTICLE VI  
BOARD OF DIRECTORS; ELECTIONS**

The directors of the Corporation will be elected as provided in the Bylaws of the Corporation. At the annual meeting of directors, directors shall be elected by the Board of Directors. The directors shall serve without compensation.

The annual meeting of the directors shall be held on or about the 31st of December each year.

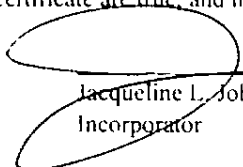
