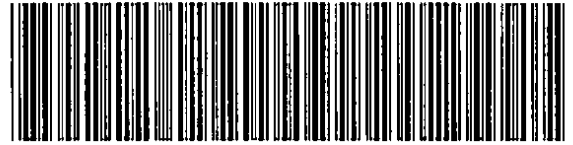

ARTICLES OF INCORPORATION

Of

BRINGIN' ON BIRTHDAYS INC.

In compliance with the requirements of Florida Statutes, Chapter 617, the undersigned serves as an incorporator, for the purpose of forming a corporation not-for-profit and does hereby certify:

ARTICLE I

NAME OF CORPORATION

The name of the corporation is Bringin' on Birthdays Inc.

ARTICLE II

PRINCIPLE OFFICE OF THE CORPORATION

The principle office and mailing address of the Corporation shall be 8 Bel Air St. #A, Maitland, Florida 32751.

ARTICLE III

PURPOSES AND POWERS OF THE CORPORATION

Bringin' on Birthdays is a non-profit organization relentlessly dedicated to positively impacting the quality of life for breast cancer victims, at risk and/or underprivileged children, and people encountering emotional life complexities, through measures that support, educate, and empower them through their tough times and difficulties.

This Corporation does not contemplate pecuniary gain or profit to its members, and the specific purposes for which it is formed are:

(1) exclusively for charitable, educational, religious and/or scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or under any corresponding provisions of any subsequent federal tax laws governing the distributions to organizations qualified as tax-exempt; and

(2) except as limited by the Articles of Incorporation and the Bylaws, the Corporation will have and exercise all rights and powers in furtherance of its purposes as are or may hereafter be conferred on not for profit corporations pursuant to Chapter 617, Florida Statutes, and in accordance with other applicable law.

Notwithstanding any other provision of these Articles of Incorporation, this Corporation shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501 (c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding provision of any future United States Internal Revenue law.

This corporation's functions, operations, programs, and pursuits are incidental to a fully recognized non-profit corporation of support, empowerment, awareness building, nurturing, mentoring, education, inspiration, and motivation for breast cancer victims, at risk and/or underprivileged children, and people encountering emotional life complexities in a relentless pursuit of enhancing their quality of life.

We will utilize churches, the corporation's website, social media, public venues, schools, and libraries to host support groups, furnish educational researched facts, informational lectures, relevant statistics, and other researched educatory information pertaining to the nurturing, mentoring, educating, inspiring, motivating, and building awareness of breast cancer victims, at risk and/or under privileged, and people encountering emotional life complexities.

We will raise awareness on the causes of, symptoms of, the treatments for, the ongoing pursuit of a cure for, and inspirational and motivational support for breast cancer patients, survivors, family members, and co-survivors affected by this horrible disease throughout their journey.

We will equip at risk and/or under privileged children with the confidence, core life skills, and the motivation they need to make positive beneficial changes in their lives.

We will provide people encountering emotional life complexities with support, empowerment, and inspiration in a continuing effort to relieve them of some of their emotional difficulties and aid them through their struggle.

Our programs entail raising awareness socially on these causes at the local level and nationally, and holding events that raise funds to aid in assistance with resources for breast cancer victims affected by this horrible disease, at risk and/or underprivileged children, and people encountering emotional life complexities irrespective of their age, race, sex, religion, ethnicity, or sexual orientation. Research for a cure for breast cancer, organizations who advocate for at risk and/or underprivileged children and organizations in support of people encountering life complexities locally and nationally will benefit from our fundraising activities.

In a pursuit of augmentation of the corporation's impact on present endeavors, we will look for collaboration with different organizations and foundations with a purpose that is exclusively educational and /or charitable, and the organization is recognized by the Internal Revenue Service as a tax-exempt 501(c) (3) non-profit corporation.

At times, at the discretion of the board of directors we may provide internships or volunteer opportunities which shall provide opportunities for said activities and programs in order to have a greater impact for change.

Bringin' on Birthdays is designated as a public benefit corporation.

ARTICLE IV

MANNER OF ELECTION

The affairs of this Corporation shall be managed by its Board of Directors. The method of election or appointment of the Board of Directors shall be fixed and governed by the Bylaws of the Corporation.




