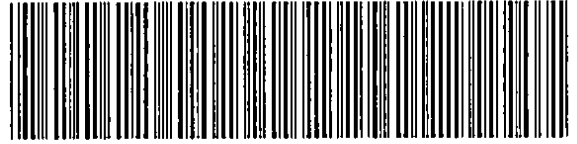

OF
NATIONAL COMMUNITY RENAISSANCE OF FLORIDA, INC.

ARTICLE III: PURPOSE

National Community Renaissance of Florida, Inc. ("Corporation"), is a nonprofit public benefit corporation, organized exclusively for public and charitable purposes, within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The specific purpose of the Corporation is to acquire, own, operate, or manage housing facilities to the poor and distressed and thereby facilitate the provision of safe, decent, and sanitary affordable housing to lower income individuals and families, thereby lessening the burden of governments of the cities of Florida by assisting such cities in the development of affordable housing, as defined by Florida State Law, as it may be amended from time to time.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

The property of this corporation is irrevocably dedicated to the purposes set forth above, and no part of the net income or assets of the Corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person.

Upon the dissolution or winding up of the Corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the Corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable, educational and/or religious purposes and which has established its tax-exempt status under Internal Revenue Code section 501(c)(3).
